Thank you for all members of the GCANA for giving me the last 12 months to act as our regional member and I have learnt many things from being apart of I the last 12months. I will provide an update for from the last Regional meeting 5-6th March 2022.

I would like area to discuss the possibly of GSR using the online GSR report from on NA.org.au. This would help with paper waste, and printing of the template GSR report along with allowing groups to have access to the forms during their group conscience which in turn they can also submit if a GSR would not be present. The online forms would atomically be emailed to the sectary.

ARSC Notes:

Amended RCM treasure report update to included \$1500 fund flow.

ARSC proposal to record ARSC meeting to keep up to date minutes, Proposal endorsed by consensus

SPAD project book has not been officially approved and RD informed that this is not official NA literature.

ARSC has a regional debit card however is in treasures name. Uses wise debit card.

Policy Subcommittee:

Details and amendments need to be made to the policy document due to cut off dates of dec ARSC. NA website policy, goes to PDF document which is searchable but was not protected by NA firewall there for edits were being made from people outside NA. Subcommittee members are working on and new policy site on na.org.au that now has subheadings and easy access links to take you directly the appropriate page in the policy. (not currently live yet.)

Discussion period: RD discussed concerns regarding funds/treasurer report from the APF.

Australia challenged treasurer report at the APF regarding budget for 2022 and spending from pervious yr 2021. Concerns were raised that money is being held/spent with no budget from subcommittees.

Australia sent 61% of funds to APF in the last yere approx. \$25000. APF calculated estimated expenses for 2022 APF conventions and APF meeting for Dec 2021 for \$7000 this means the APF are predicting that \$17000 will be spent in 8 weeks prior pr APF convention and meeting, Australia questioned this as this would not happen. \$5000 was budget for Women's FD and FD however there was no breakdown of what this would entail :ie flights, workshops, events

Australia fund flows a 1/3 of the APF totally revenue for the year 2021.

Australia also discussed concerns that when APF doesn't budget for the year that they are automatically stating that Australia will be able to fund flow \$25000 a year when the budget is
