Far Noth Coast: Experienced a member who was displaying strange behaviour not targeting the certain individual instead of targeting the person they read pertinent literature and included them.

Indigenous Chair: I can be difficult with first nations people there is controversial topics, always in communication with the subcommittees, Exercise gentle hands and a warm heart.

Gold Coast: Medical Cannabis, maintenance, replacement therapy, Outside issue?

Are we crossing the lines with outside issue stuff around doctors to patients, as a medical replacement therapy, if it is prescribed by a doctor for any mental health issues, can we create a preamble if needed.

If a person is stoned in the meeting, do we stop them from sharing, can be a confusing message does it deter a newcomer or make them think it is ok to distinguish between substances since we are a abstinence based program. Sydney East reverted us to the times of illness pamphlet, talking about medical use as being a decision between an addict their sponsor their doctor and their higher power.

Sunshine Coast: As a fellowship we are going to be faced with these challenges this goes back to our discussions around responding to certain trends. We must consider all possibilities. And not push people away from meetings.

#### **PR Chair Report 31/3/2024:**

Doing a PR presentation in April for convicted drug offenders at Coomera organised by Probation and Parole.

Further to the discussion at last GCASC meeting, I made enquiries with Go Transit who handle the advertising on Kinetic Gold Coast buses. The local rep got back to me after several calls and stated that the minimum commitment is to take the two advertising panels per bus on 100 buses, (which is half the GC fleet) for a month. The normal cost is \$4,400 for a single month, reducing for longer commitments. Based on advertising on the outside of the bus, not-for-profits receive half discount. I stated that I was unsure if even at \$2,200 whether we could afford it. The rep said she would take it back to her manager to see if they could offer us a better deal.
