Treasurer's Report 2020-2021

Dear Members

It is an honour to provide the second Treasurer's Report for the Regional Service Body of Australia Incorporated (RSBoA Inc), covering the period 1 July 2020 to 30 June 2021.

Income

Income for the period 1 July 2020 to 30 June 2021 was \$151,262.14, which represented a 15% increase from the previous financial year. This is encouraging given that we are still experiencing a pandemic.

Expenses

Base expenses for the same period totalled \$43,362.09. These were all in line with approved budgets.

Significant items related to Audit Fees, Base Fund Flow to APF and NAWS, Insurance, IT Twilio Phoneline and Website, Legal Status Incorporation and NA Today Printing.

Additional expenses totalled \$146,729.92, all of which were for Additional Fund Flows to NAWS. These were available funds, approved by the ARSC, that were over and above the prudent reserve and not committed for ARSC use.

A breakdown of all income and expenses are included within this report.

<u>Audit</u>

DKM Accounting and Taxation Services were appointed to complete the annual Agreed Upon Procedures Engagement for 2020-2021.

The engagement involved the following:

Review and test the transactions within the Regional Service Body of Australia Incorporated Bank Account to supporting documentation for the period 1 July 2020 to 30 June 2021.

The findings were as follows:

A total of 214 transactions had taken place in the Regional Service Body of Australia Incorporated Trust Account during the period 1 July 2020 to 30 June 2021. All of the transactions were able to be substantiated as sufficient supporting documents were provided.

There were no exceptions noted.
